- 1. The board of directors recommends that Jeffrey Greenwell be elected as President of the Association for 2023/24.
- 2. Jeffrey Greenwell was Chief Executive of the county council in the 1970s and 80s and has been involved with Northants CALC for 44 years. His first sojourn as President was 1979 to 1996, and he stood in again in 2007/08. Jeffrey stood in as President from 2019 to 2021 and was then appointed fully at the 2021 AGM.
- 3. The board of directors recommends that Kate Brown Accountant (<u>see website</u>) be reappointed as the Association's auditor for the year ending 31 March 2024.
- 4. Kate Brown is a chartered accountant with over 20-years' experience. Having worked with individuals and businesses of all sizes, she has been based in Northamptonshire since 2001 and enjoys working with local clients and businesses across the country. The firm was first appointed as the Association's auditor in 2014.
- 5. Northants CALC is a company limited by guarantee. It is exempt from statutory audit because it has a turnover of less than £10.2 million and fewer than 50 employees. However, the board of directors feels that it is important to maintain an independent inspection of the Association's accounts to provide assurance to member councils.

Corporate Report

By far the biggest event in the reporting period was the death of Her Majesty Queen Elizabeth II on Thursday 8 September 2022; a poignant moment in the life of the nation and a moment for parish and town councils to step forward in their civic leadership role. Northants CALC is pleased to report that parish and town council in Northamptonshire conducted themselves impeccably throughout, and that this was recognised by the Lord Lieutenant of Northamptonshire, James Saunders Watson, who gave thanks and said he was "extremely proud" of the way parish and town councils had acted. Northants CALC had been readving member councils for "Operation London Bridge" (OLB) for well over fifteen years and had well-oiled plans worked up in partnership with the principal councils. Our first OLB briefing following The Queen's death went out at 0900 on the Friday and we issued daily briefings at 0900 to all parishes through to the following Wednesday. The range of enquiries we received was incredible, but the Association pulled out all the stops to be there for our member councils. The staff team had very little sleep that weekend, but councils appreciated the clear, timely, and ordered advice and guidance, which helped them manage the situation calmly and efficiently.

The Association's big project in the reporting period was the Asset Mapping Project (AMP) funded by the UK Community Renewal Fund (CRF). We distributed over £100,000 of CRF grant monies to parish and town councils in Northamptonshire for them to map assets and services in their area that are currently delivered by the unitary councils. Over ten thousand map points were created on a shared mapping layer in Parish Online, which provides a vital evidence base for devolution. The project was due to finish in June 2022 but was extended by the government until 31 December 2022, which provided further opportunity to work with the unitary councils to shape the relationship between the tiers, should wholescale

devolution appear on the table.

Northants CALC was recognised for its pioneering work by the National Association of Local Councils (NALC) awarding us CALC Project of the Year 2022 at the Star Council Awards.

Another huge internal project was the recovery of historic VAT. Due mainly to our activities during Local Government Reorganisation (LGR), in October 2020 Northants CALC reached the threshold for compulsory VAT registration. VAT collection began on 1 April 2022, so the Association had to decide what to do about the VAT that should have been charged between October 2020 and 31 March 2022. The board agreed that because parish and town councils can reclaim VAT on non-business expenditure, we should invoice for the historic VAT. The total amount of historic VAT was £42,861.94, and it is pleasing to report that after a lot of hard work, by 31 March 2023 we had received 89% of this amount. The Association is indebted to its member councils for their co-operation and support during this project. It is expected that 100% of the VAT will be recovered in due course.

The Association works to a three-year Strategic Plan, and as the 2020 – 2023 ended we started work on the 2023 -2026 plan. The timetable and process were agreed by the board at its Annual Board Away Day on 16 June 2022 and a first draft was received at the September board meeting. Member workshops were held in January 2023 (one for clerks, one for councillors) to ensure that the new Strategic Plan was rooted in the needs of member councils. The board adopted the final iteration at its meeting in March 2023. The Strategic Plan 2023 - 2026 guides our activity but the Association remains extremely agile and ready to deal with anything that comes along.

The board itself has worked very well during the reporting period and has had stable membership with no leavers or joiners. This is important because it allows the board to develop as a team and for the dynamics to mature to a point where the entire focus of the board is on member services and benefits. The board is led by its chair, Mike Scott (Great Addington), who will complete his three-year term of office in November 2023. The board meets ten times per year with a mix or remote, hybrid, and in-person meetings and all eight directors are councillors or clerks from member councils in the county.

Since November 2022 the Association has been working in partnership with the unitary councils to develop the Local Area Partnerships (LAPs) across the county. The Association's directors and staff had focus sessions in spring 2023 with West Northamptonshire Council (WNC) at the Guildhall, Northampton. and with North Northamptonshire Council (NNC) at the Corby Cube. Parish and town councils have a hugely important role in health and wellbeing, and they will be key partners in the delivery of the Health & Wellbeing Strategy for Northamptonshire being developed by the new Integrated Care Board.

Northamptonshire is of course the focus of the Association, but it also plays a critical role regionally and nationally in terms of lobbying and policy development. One way it can do that is by putting motions to the National Association of Local Councils (NALC) and in July 2022 a two-part motion was submitted: 1) That NALC recognises that the workforce challenge is one of the biggest challenges of our time and that there is an issue with recruitment, retention, and capacity in local councils, and 2) That NALC engages a consultant

to benchmark clerks' terms and conditions. The motion recognised the importance of high calibre clerks to the sector and the challenges that member councils have had recently in terms of recruitment. The motion was carried unanimously and pursuant to it NALC set up the National Employment Strategy Advisory Group (NESAG) and has engaged with the Local Government Association to carry out a workforce review. Northants CALC is one of three CALCs represented on NESAG to bring this very important work to fruition.

The Association's staff team is passionate about providing excellent service to member councils and is dedicated to providing ever greater value for money. It is our pleasure to keep supporting you and your council to do all the wonderful things you do for your community.

Finance Report

The accounts for the year ending 31 March 2023 are appended to the Annual Report. The accounts are independently inspected by Kate Brown Accountants, Chartered Accountants, and submitted to Companies House under the requirements of the Companies Act 2006.

The Association maintains a system of internal controls to ensure the effectiveness and efficiency of its activities and operating procedures. A director is appointed with responsibility to scrutinise the internal controls and working practices, which has proved to be a very useful governance tool that helps improves risk identification and mitigation. The Internal Controls Director (ICD) carries out a minimum of three checks per year and may check any system or procedure at will.

The Association ended the financial year with an apparent surplus of £141,189, but this is mainly because Community Renewal Fund (CRF) funds were received in the financial year, but project costs continued after year end and will show in the next year's accounts. Similarly, recovered historic VAT shows in the year ending 31 March 2023 and will be an outgoing in the year ending 31 March 2024.

Looking at the background finances (excluding the CRF grant & VAT) our income from membership subscriptions was down 7% on the previous year, due mainly to Kettering Town Council (KTC) and Wellingborough Town Council (WTC) withdrawing from membership on 1 April 2022. We are working hard to demonstrate to both councils that membership is fantastic value money. and that all councils have a responsibility to support the existence of a county association. All councils benefit from the work of the Association, so if it continues to exist then all councils have a responsibility for it.

Overall, total income was 99% of budgeted income and total expenditure was 87% of budgeted expenditure, so the outturn was better than expected.

Even though there is a large surplus for the year ending 31 March 2023, the Association has planned deficit budgets again for the next three years as reserves are managed down to policy targets.

The Association is well placed to cope with the short and medium-term financial outlook.

Corporate Governance

The board operates according to the following principles:

The board should be independent of the staff:

The board has determined that each director is independent in character and judgement and that there are no relationships or circumstances which are likely to affect their judgement or impair their independence.

Directors should be submitted for reappointment annually:

Recommendations for re-appointment should not be assumed but be based on disclosed procedures and continued satisfactory performance.

There should be full disclosure of the board's membership:

A list of directors with biographies is available on the Association's web site.

The board should aim to have a balance of skills, experience, and knowledge:

The board operates a Composition & Diversity Policy so that the board contains a good mix of clerks and councillors from small and large councils.

The board should undertake an annual review of its own performance:

All directors complete self-assessment forms that help identify the strengths and weaknesses of the board.

The board should give attention to overall strategy:

The board monitors performance against its agreed strategy on an ongoing basis and reviews its overall strategy, including the viability of the Association in its current form.

Auditor

At the AGM held on 1 October 2022 Kate Brown Accountants was appointed as the auditor for the year ending 31 March 2023.

Membership Fee

In Northamptonshire as at 31 March 2023 there were 203 parish councils, 17 town councils and 51 parish meetings (civil parishes without a parish council). The largest council is Northampton Town Council (electorate 89,346) and the smallest council is Brampton Ash Parish Council (electorate 65). The smallest parish meeting is Althorp Parish Meeting (electorate 7). The highest precepting council in 2021/22 is Northampton Town Council (£1,807,837) and the lowest (of the ones that precept at all) is Catesby Parish Meeting (£90). Together, councils in Northamptonshire raised £19.6 million in precept in 2023/24.

98% of the councils in the county are in membership of the Association. The membership fees are set by the AGM each October.

Internal Audit Service

parish and town councils in Northamptonshire used the Internal Audit Service from Northants CALC for the year ending 31 March 2023.

A team of specialist auditors are contracted by the Association to provide the service to parish and town councils,

ranging from the smallest with annual expenditure of less than £1,000 to the largest with annual expenditure more than £2,000,000.

The purpose of internal audit is to review whether the systems of financial and other controls over a council's activities and operating procedures are effective.

The internal audit function must be independent of the other financial controls and procedures of the council. The person or persons carrying out internal audit must also be competent to carry out the role in a way that will meet the business needs of each local council.

Member Enquiry Service (MES)

The Member Enquiry Service (MES) is an email-based enquiry service for member councils that provides a timely response to non-complex, generic enquiries.

In the year to 31 March 2023, MES responded to 158 enquiries from member councils on an extremely diverse range of subjects.

MES operates on a volunteer basis, staffed by a team of four expert and dedicated clerks, all of whom are CiLCA qualified.

Data Protection Officer (DPO) Service

The DPO

Data Protection Service provides councils with a dedicated email address and named officers to act as DPO. The role of the DPO is to inform and advise the Council and its employees about their obligations to comply with the General Data Protection Regulations (GDPR) and other data protection laws, to monitor compliance and advise on data protection impact assessments, train staff, and conduct internal audits.

The DPO is the first point of contact for supervisory authorities and for individuals whose data is processed (including employees, councillors, and members of the public).

189 of the county's parish and town councils subscribed to the DPO Service in 2022/23.

Local Council Award Scheme (LCAS)

The National Association of Local Councils (NALC) has refreshed the Local Council Award Scheme (LCAS).

All councils are encouraged to consider going for accreditation. There's a level for everyone: Foundation recognises sound standard practice; Quality recognises good practice and Quality Gold recognises best practice in all aspects. Councils can accredit at one level and then work towards a higher level if they choose.

Police Liaison Representative Scheme

A Police Liaison Representative (PLR) is appointed by a council to act as a single point of contact for the police. It is the same principle as the Parish Paths Warden Scheme for rights of way and the Highways Representative Scheme for highways. The scheme was revitalised in 2021 and as of 31 March 2023, 197 parishes had appointed a PLR. The intention is to grow and develop the scheme in the coming vears.

Councillor Panel

Approximately 120 Councillors are registered on the Councillor Panel, which operates on an e-mail basis. We send out questions and surveys and give members of the Councillor Panel a few days to respond. The results are used as a guide, and they help inform our work. It's not a formal consultation mechanism and the responses are those of individual councillors, not councils, but it does give us a very quick and costeffective way of engaging with Councillors.

The Councillor Panel is extremely useful to the Association and all councillors are encouraged to sign up for it, even if just on a trial basis. Just send an email to info@northantscalc.com with your expression of interest and you will be added to the distribution list. Typical response rates are in the order of 50 – 70%, so not every member of the panel responds to every survey. The board of directors recommends that the **per council** element of the Northants CALC membership fee for the year starting 1 April 2024 and ending 31 March 2025 be increased by inflation (CPIH July 2023 – 6.4%) from £181.43 to £193.05.

The board of directors recommends that the per elector element of the Northants CALC membership fee for the year starting 1 April 2024 and ending 31 March 2025 be increased by inflation (CPIH July 2022 – 6.4%) from 27.23 pence to 28.97 pence.

Larger councils (10,000-30,000 electorate) are charged a fixed fee for membership of Northants CALC. The board of directors recommends to the AGM that the fixed fee per council for the year starting 1 April 2024 and ending 31 March 2025 be increased by inflation (CPIH July 2023 – 6.4%) from £2,902.93 to £3,088.72 per council. The total fee payable will therefore be (£3,088.72 + NALC Affiliation fee capped at £2,037*). The equivalent fee for super councils (30,000 + electors) is increased from £5,273.44 to £5,610.94. The total fee payable will therefore be (£5,610.94 + NALC Affiliation fee capped at £2,037*).

Parish Meetings with less than 100 electors AND no precept are offered affiliate membership for 2024/25 free of charge. The maximum fee that **any** council or parish meeting pays is capped at £1 per elector.

Commentary

- 1. For the past eight years the board has recommended an increase in the membership fee by inflation as determined by the Consumer Prices Index (Housing) (CPIH) for the July preceding the AGM.
- 2. CPIH for July 2023 was 6.4%.
- 3. Inflation forecasts suggest that rates will reduce in 2023 and 2024 and stabilise at 2% from 2026.
- 4. At the board meeting held on 21 September 2023 there was a full discussion about subscription fees, affordability, and value for money.
- 5. The board carefully considered all options and agreed by 7 votes to 1 to adhere to the policy of recommending to the AGM an increase in line with CPIH July, 6.4%. The board focused on the real terms increase (see table above) and felt that the increase protected services and still represented very good value for money.
- 6. Northants CALC is a not-for-profit Association, whose income is used purely to provide member services to local councils in Northamptonshire. It does not have shareholders and does not distribute profits. Every penny is used solely for the benefit of member councils.
- 7. In accordance with the constitution, the setting of membership fees is a matter for the AGM, based on a recommendation from the board of directors.

Recommendations:

That the AGM approves the recommendation of the board of directors to increase membership subscription fees for the year ending 31 March 2025 by CPIH July 2023 (6.4%)
