Roger Clarke - Gayton Parish Council	Why has the planning department been allowed to become so depleted? I speak as a former Planning portfolio holder with SNC when the management plan you have described was already in place. S many talented 'planning officer' have left since the new formulation of Council!	The change to a Unitary did result in many staff leaving, there is no single factor to explain this. In September 2023 the Planning Service commenced a large-scale permanent staff recruitment campaign following an internal restructure. The permanent recruitment is still on-going; but at the time of writing the Planning Service now has new officers in post for the following development management positions (almost all of the posts it advertised in the Autumn of 2023): - 5 technical support posts (Admin posts tasked with validation/other key support tasks) - 1 Permanent Head of Development Management - 2 Experienced Principal Planners - 1 Major Project Officer - 5 Senior Planners in Area teams- 4 Planning Officers in Area Teams and 3 Graduate Planner Posts (this in

		addition to a small number of planning policy, ecology and S106 officer posts).
Steve Roper, Cold Ashby Parish Council	Are the recruitments permanent recruitments	Yes (no new agency staff in above list).
Clive Hockley, Hinton in the Hedges Parish Meeting	It just sounds like there are now loads of people trying to implement these changes how many are actually dealing with planning applications?	The North and South Area Planning teams were carrying a lot of vacant posts as of June 2023 (over 1/3 vacant posts, but some agency cover). As of mid-June 2024 one team has 15/15 officer posts filled (including a new starter in early June), the other (also 15 staff when full compliment) has one vacant post and one staff member on maternity leave. There is no longer use of any agency staff in the two area planning teams.
Ann Ranshaw, Weedon Bec	What are the agreed timescales for responding to planning applications and when they are exceeded what updates/explanation will a parish receive?	There is a standard 21 day consultation period (if revised plans are received the 2 nd consultation is normally14 days). If comments are received within 21 days they are automatically taken into account. We wont delay determination for late comments, but will take into account any late comments received before determination.
Nicola Butcher, Cold Higham Parish Council	Are there any stats that demonstrate the impact extensions of time have had? How many are running to 8 weeks/13 week stat times?	Validation performance was increasing use of extensions of time in 2023/early 2024. In effect if it took over 3/4 weeks on average to validate an application this was creating a surge in agreed extensions of time. Additional recruits joined the

		technical support team through January 2024, by April 2024 average validation timeframes were under 10 days, by June 2024 under 5 days. Its clear this has proportionality reduced use of AET's (validation is not the only factor which affects use of AETs, but we identified it as possibly the single biggest factor). We now have robust plans in place to ensure quick validation of applications (maintaining staffing levels being key to this). It should be noted that sometimes applicants/agents want an AET rather than a refusal (e.g. To revise plans or do extra survey work).
Jeff Servant, Wootton Parish Council	What % of applications are currently being decided within the statutory 13 week period?	Over 80% of majors are being decided within 13 weeks and over 80% of non majors in 8 weeks (this is in time and with agreed extensions of time, which is how the Government measures these statistics.
Tony Hewitt Holcot Parish Council	Is there any statistics on the pre apps this seems to where there are major delays	We re-launched the pre-application advice service (full service) in mid April 2024, it is too early to share statistics.
Alison Benson, Hackleton Parish Council	When does the 8-week turnaround on minor applications begin? I am aware of an application submitted early September which has been validated and issued a number but still doesn't even appear on the portal or the weekly list	The issues we had in late 2023 and early 2024 with delays to applications being validated have now all been resolved. Since early April, we have been validating applications within 10 working days and this enables planning officers to complete their work to issues decisions within the timescales as set out by legislation.

Jean Morgan Evenley Parish Council	Could SG please clarify if pre-app advice given to applicants (when it is reintroduced and given in past) is publicly available? Would it be discoverable via a Fol Request?	A definitive answer cannot be given on this question as any FOI response is decided not by the planning team but by the FOI team. That said pre-application advice is normally exempt (and not just at WNC, but for most Councils*). A full pre-application advice service generally leads to better planning outcomes for both residents and applicants, applicants know a planning application when lodged is subject to full public consultation; but they may wish to confidentially run through some aspects of planning pre-application advice. *It should be noted that numerous pre-application advice proposals never subsequently progress to applications (Re: If we published them all on our webpages it would unnecessarily upset thousands of WNC residents).

Alison Reynolds - Roade Parish Council	when a development has gone through appeal are all previous comments & objections from PC's residents etc forwarded across or should these be resubmitted?	Yes they are. All comments are sent to PINS (Planning Inspectorate).
Alison Benson, Hackleton Parish Council	Can planning officers please update parish councils more regularly. We have an application from July 2022 outstanding within the parish and we keep asking the officer for updates. The last response we got was 10th October saying they hoped to make a recommendation next week but still we hear nothing despite regular chasing. Thank you	Now we have more officers we expect them to respond better to requests for updates.
Clive Hockley, Hinton in the Hedges Parish Meeting	At present the officers report and the decision notice show up on the register at the same time. Several times in the recent past there have been factual errors in the officers report but the parish is unable to point them out because once the decision notice is published no one can add additional comments. Could there be at least a weeks gap between the two being published to enable errors to be corrected?	No, unfortunately we have to publish the decision the same time we make it. Unfortunately this is not a request we cassist with. AD (James Rodger) comment: I will normally get directly contacted (or forwarded mails from my managers) or any comment from a Parish Council raising a red flag in this regard; fortunathere has been a reduction in the number of such comments I have seen over the past 18 months; this is undoubtedly because of staffing changes/improvements over the past y
